A RESOLUTION AMENDING SEWER USER FEES EFFECTIVE JULY 1, 2015

WHEREAS, Section 99.06 of the Burlington City Code provides that the Burlington City Council shall by resolution establish rates to be charged for contributors to the City's Sanitary Sewer System; and

WHEREAS, it is the desire of the City to maintain the Sewer Fund, an Enterprise Fund of the City, in sound financial condition; and

WHEREAS, it has been found that to maintain sound financial condition in the Sewer Fund required an adjustment in sewer rates.


NOW, THEREFORE, BE IT RESOLVED, that for billings rendered on or after July 1, 2015, the following sewer user charges shall be in effect:

For Unmetered Contributors:	<u>Current</u>	<u>July 1, 2015</u>
1. Base annual rate for any service not to exceed six rooms not including fixtures	\$185.24	\$190.80
2. In addition to the base annual rate, the following charges will be made when applicable:		
▶ Additional rooms over six, each	\$19.16	\$19.72
▶ Minimum room rate per apartment	\$146.92	\$151.32
Fixture rates for one family dwelling:		
▶ First bathtub or shower	\$108.56	\$111.84
▶ Second bathtub or shower	\$71.84	\$74.00
▶ Additional bathtub or shower, each	\$54.32	\$55.96
▶ First water closet	\$108.56	\$111.84
▶ Second water closet	\$71.84	\$74.00
▶ Additional water closets, each	\$54.32	\$55.96
