

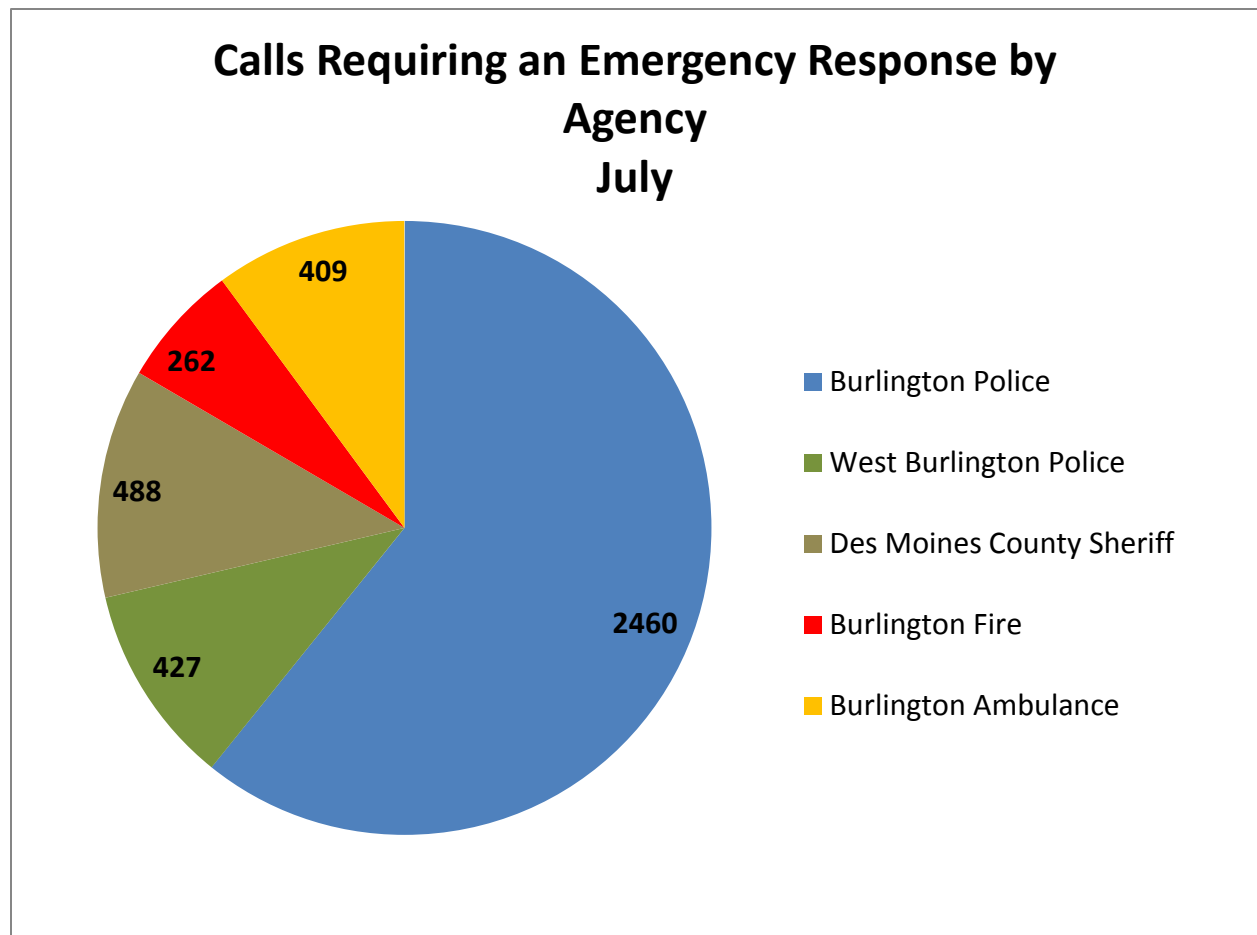

Re: Police Department Activities – July, 2016

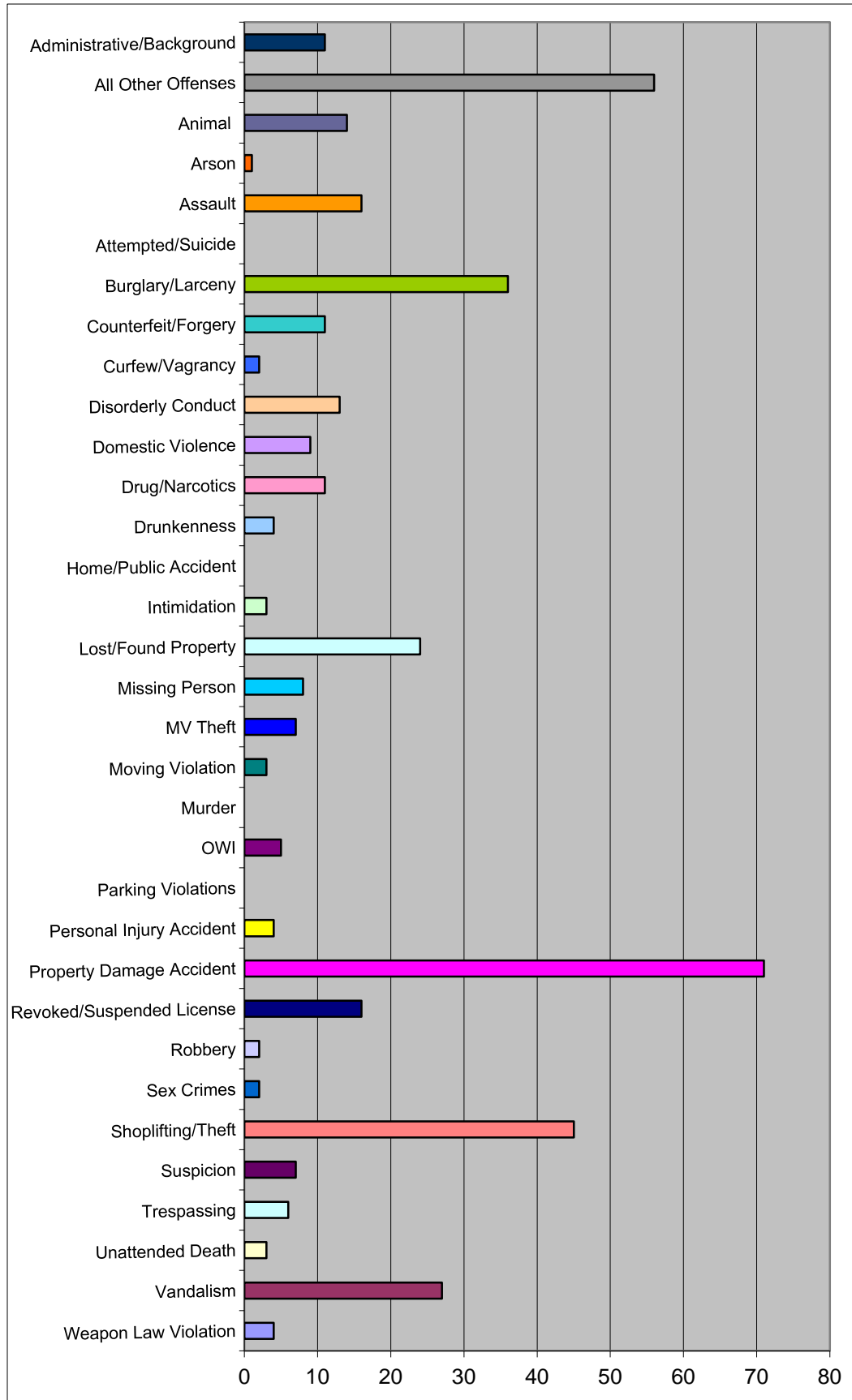


- The Chief attended all City Council Work Session and Meetings.

- The Command Staff met for the monthly staff meeting.

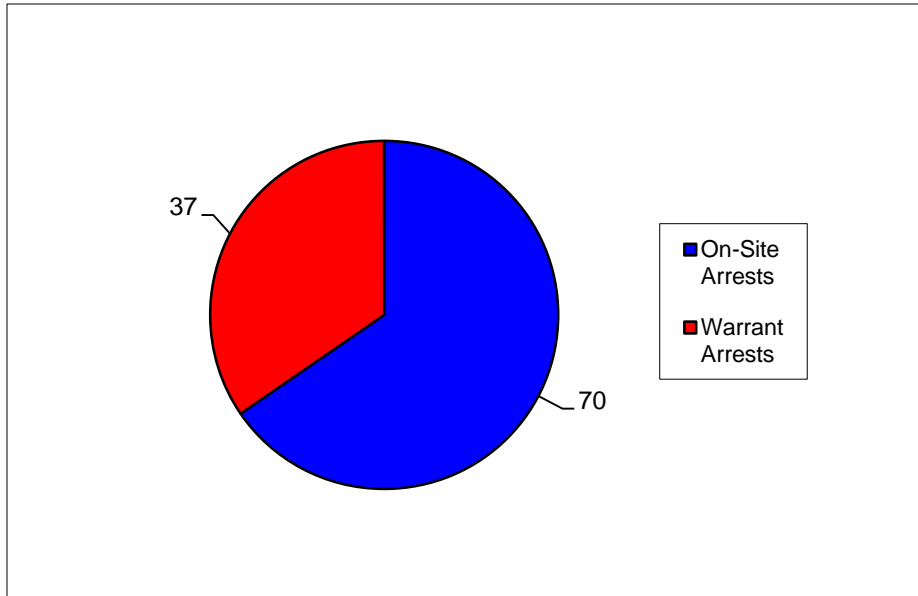
- During the month of June, there were 224 hours dedicated to education/training of officers; there were five presentations given to the public. The number of animals received at the Animal Shelter in July was 30.

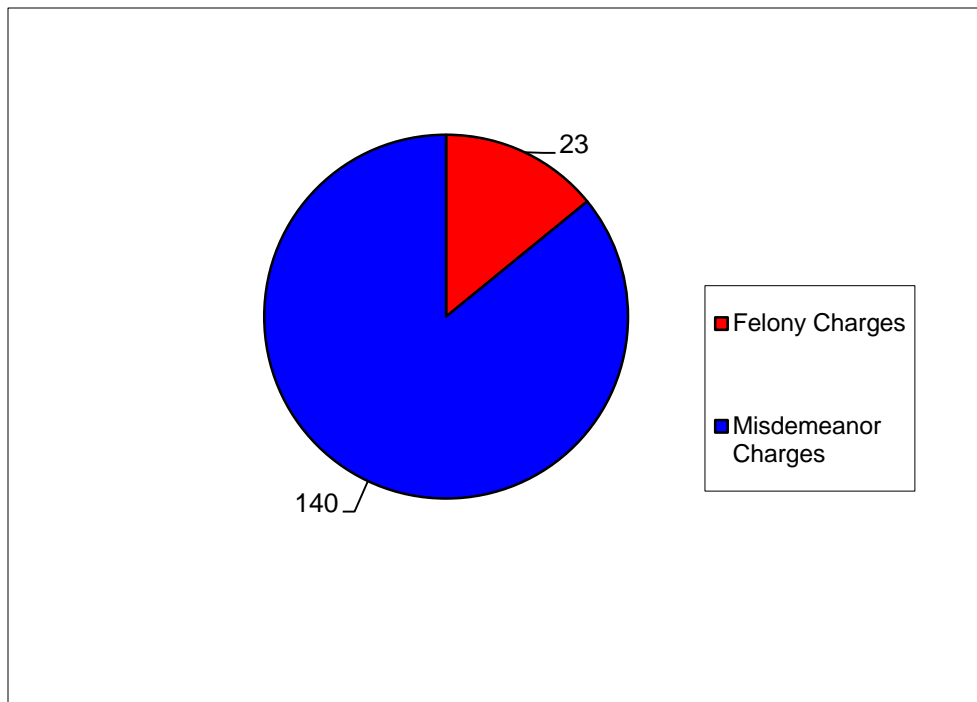
# Incidents July 2016
