

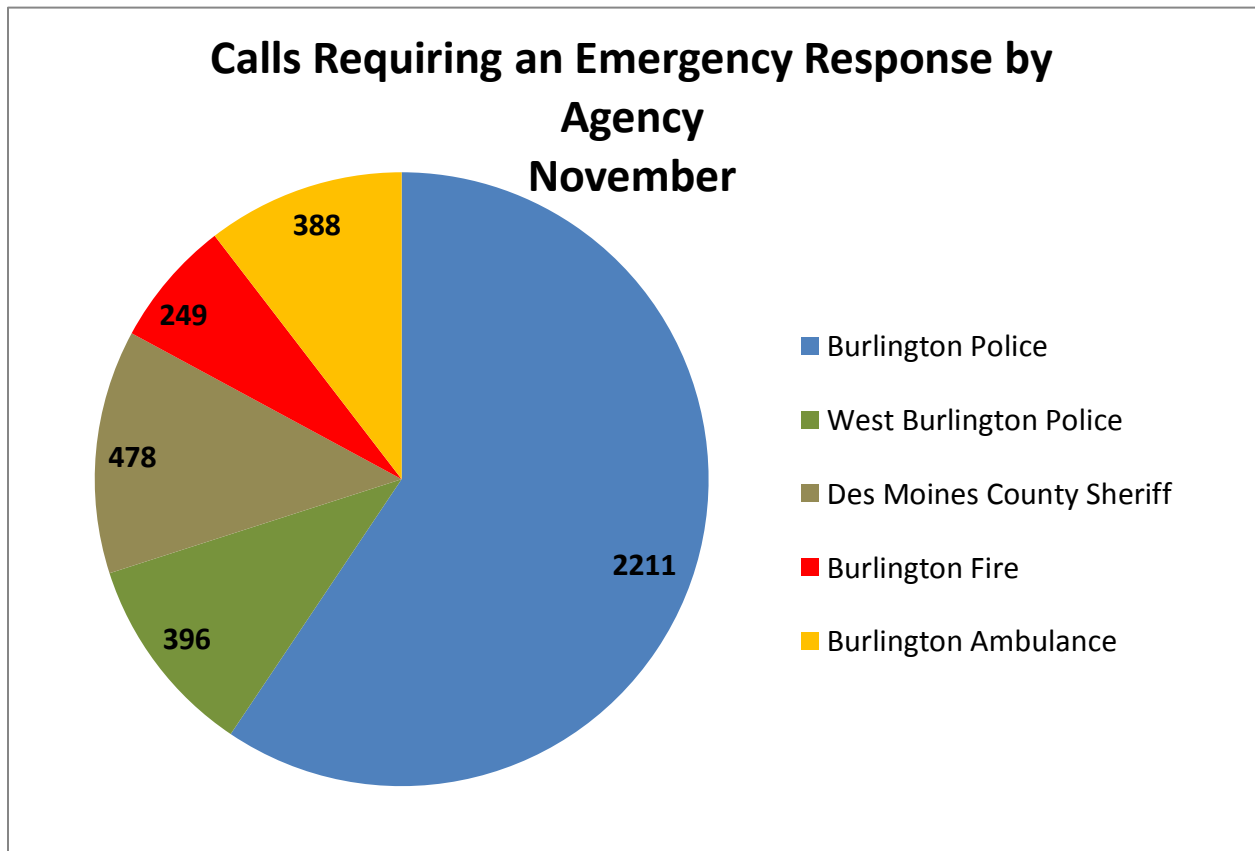

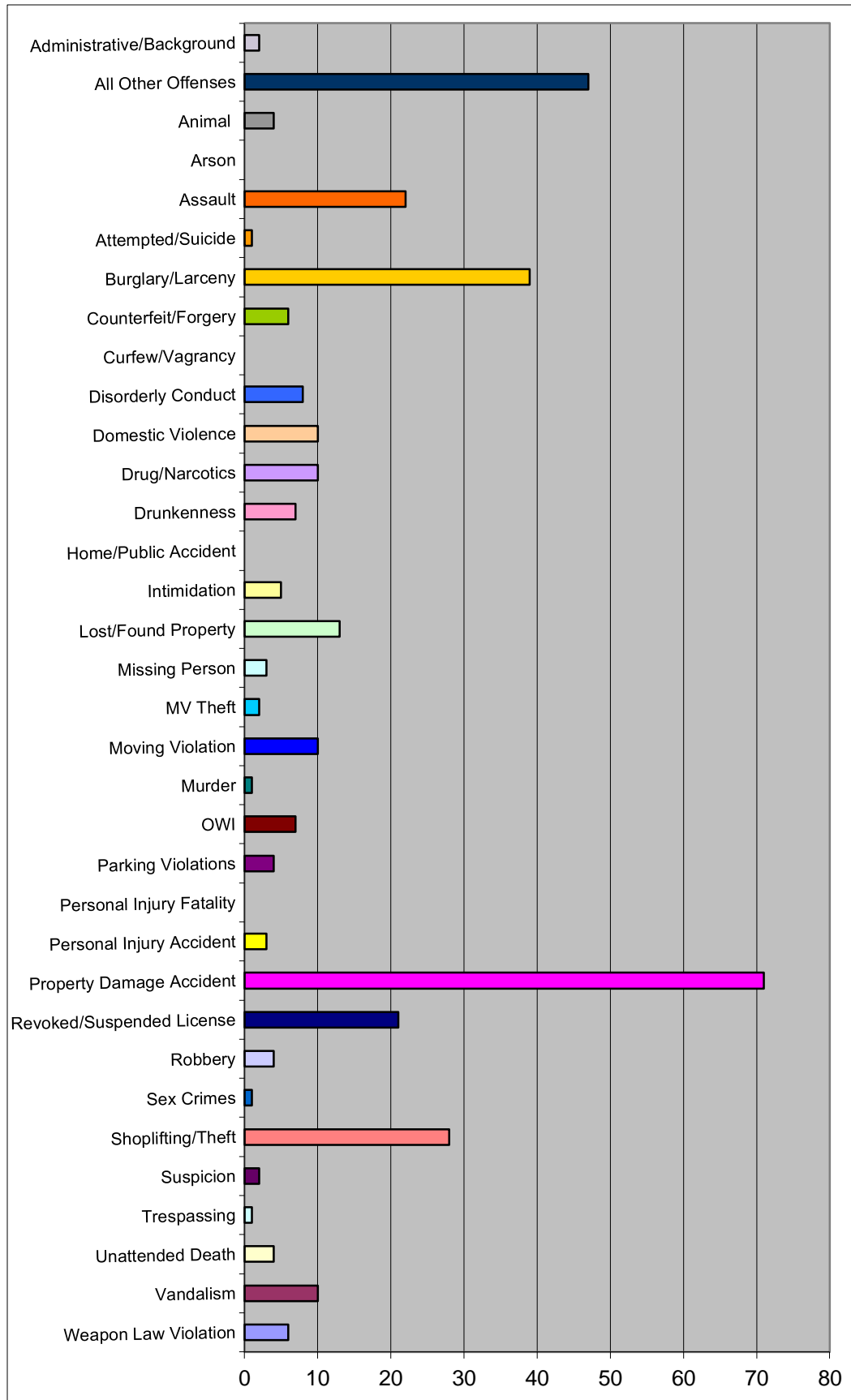


- The Chief attended all City Council Work Session and Meetings.

- The Command Staff met for the monthly staff meeting.

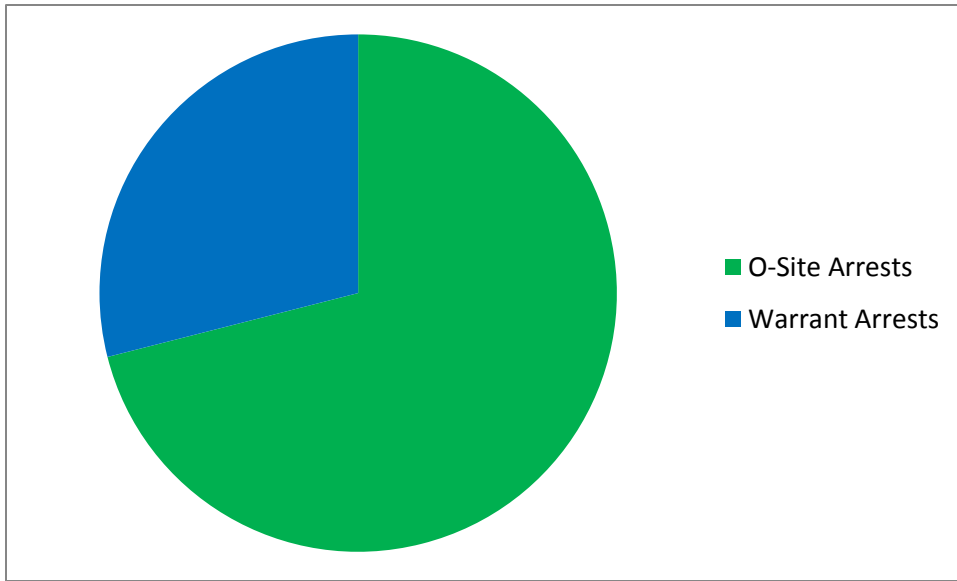
- During the month of October, there were **22** hours dedicated to education/training of officers; there were 10 presentations given to the public with **256** people in attendance.

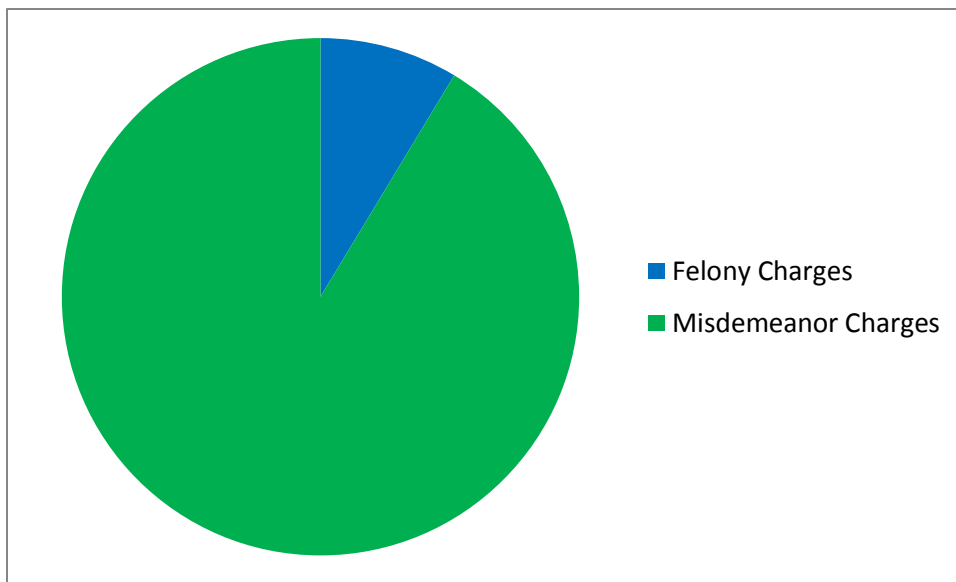
