
- The Chief and Major Kramer participated in monthly Leadership meetings at City Hall.


Incoming 9-1-1 Calls January 2014

Number of Calls: 1,341




Incoming Calls to the Communications Center January 2014




Calls for Service January 2014




Arrests January 2014
