- The Chief met with Chief Deputy White and Asst. County Attorney Beavers regarding the DesCom 28E Agreement.

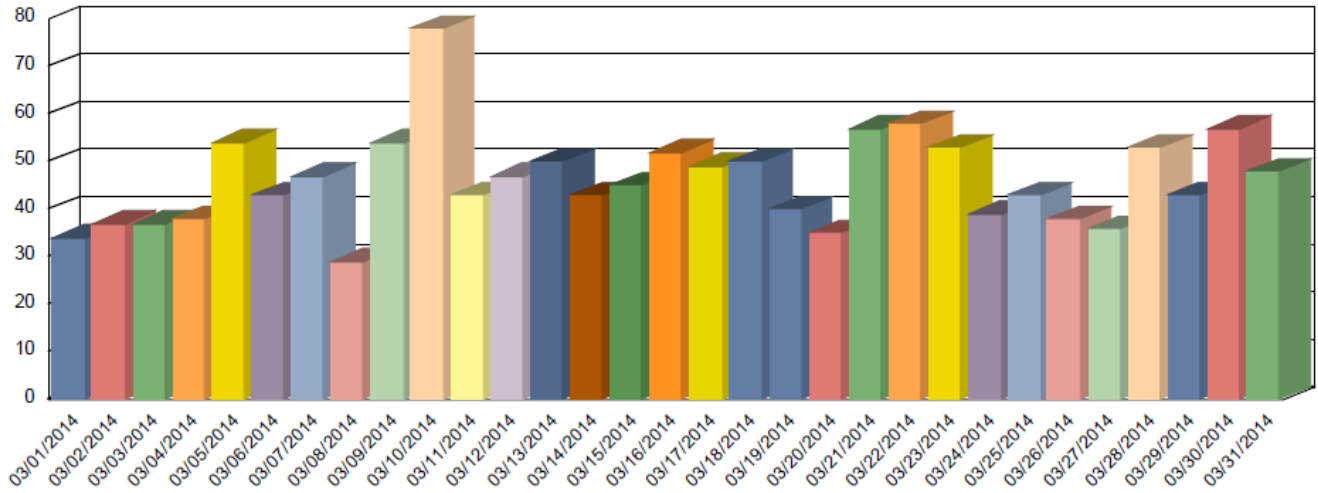

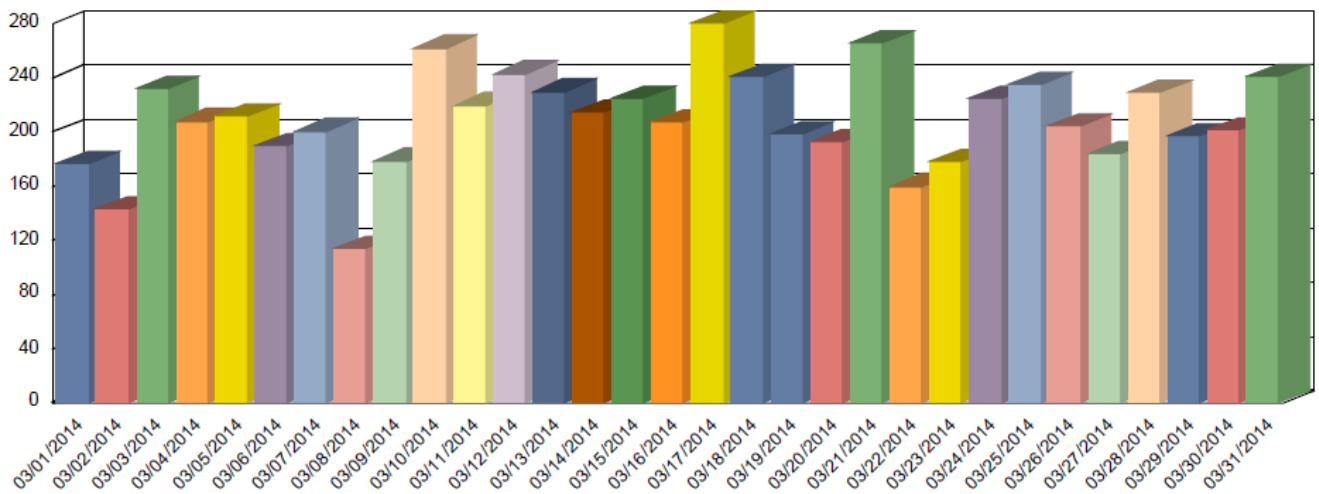
## Incoming 9-1-1 Calls March 2014

Number of Calls : 1,430

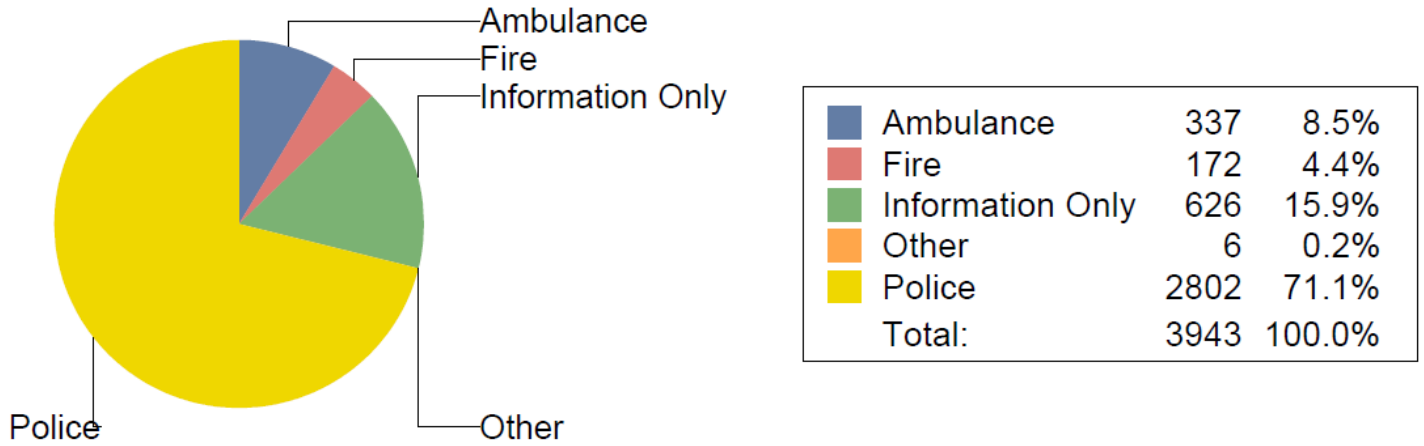


## Incoming Calls to the Communications Center March 2014

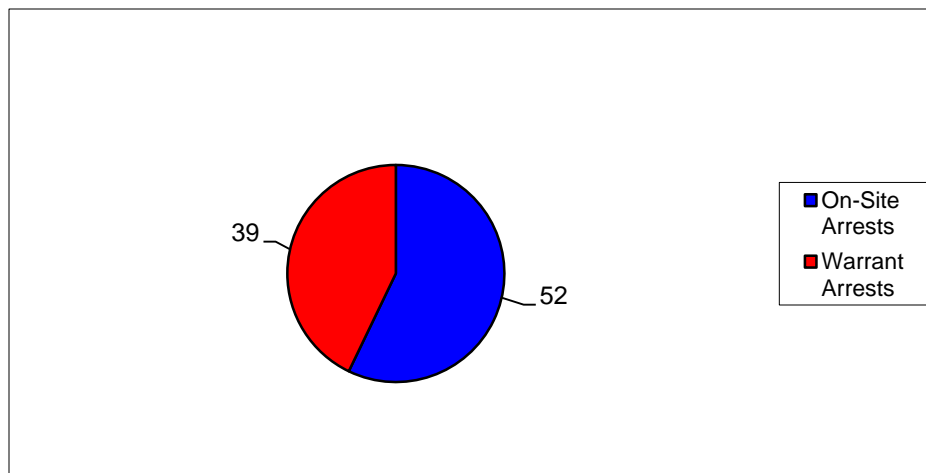

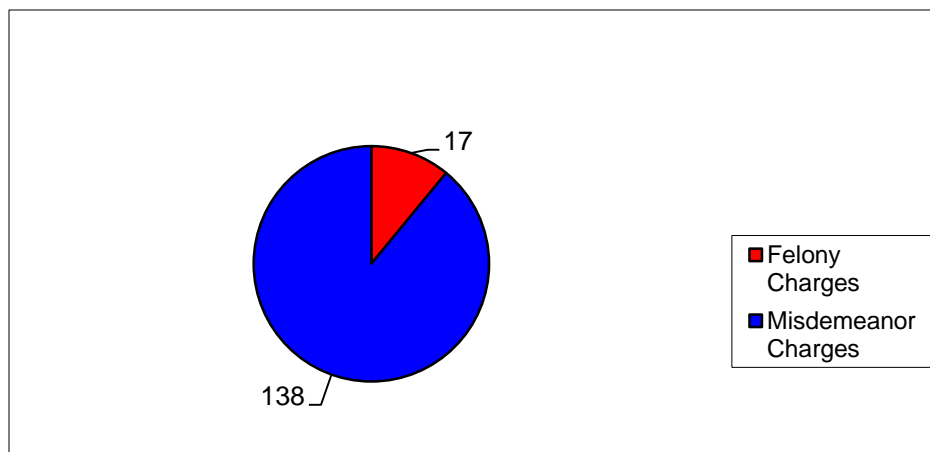
## Calls for Service March 2014



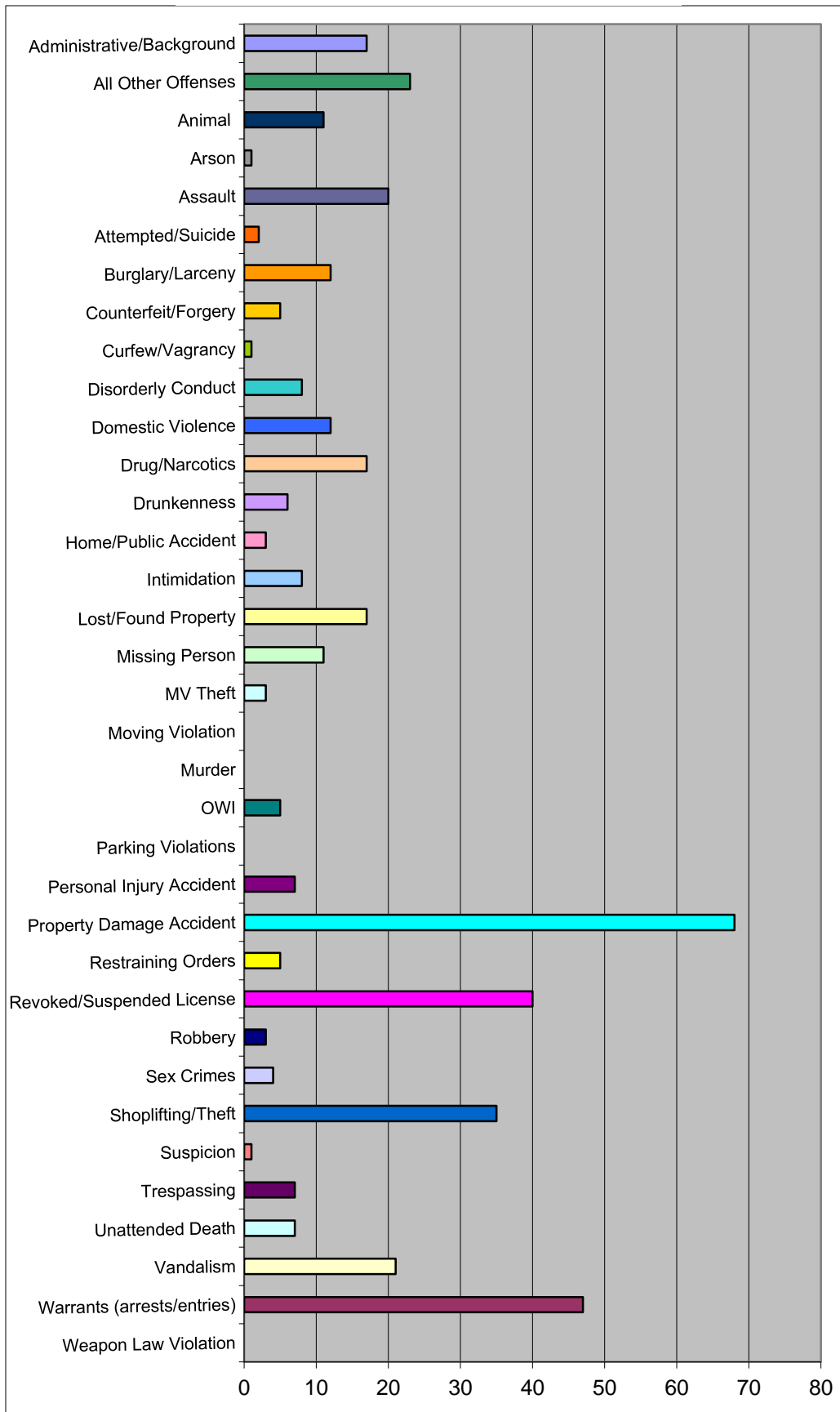
## Arrests March 2014
