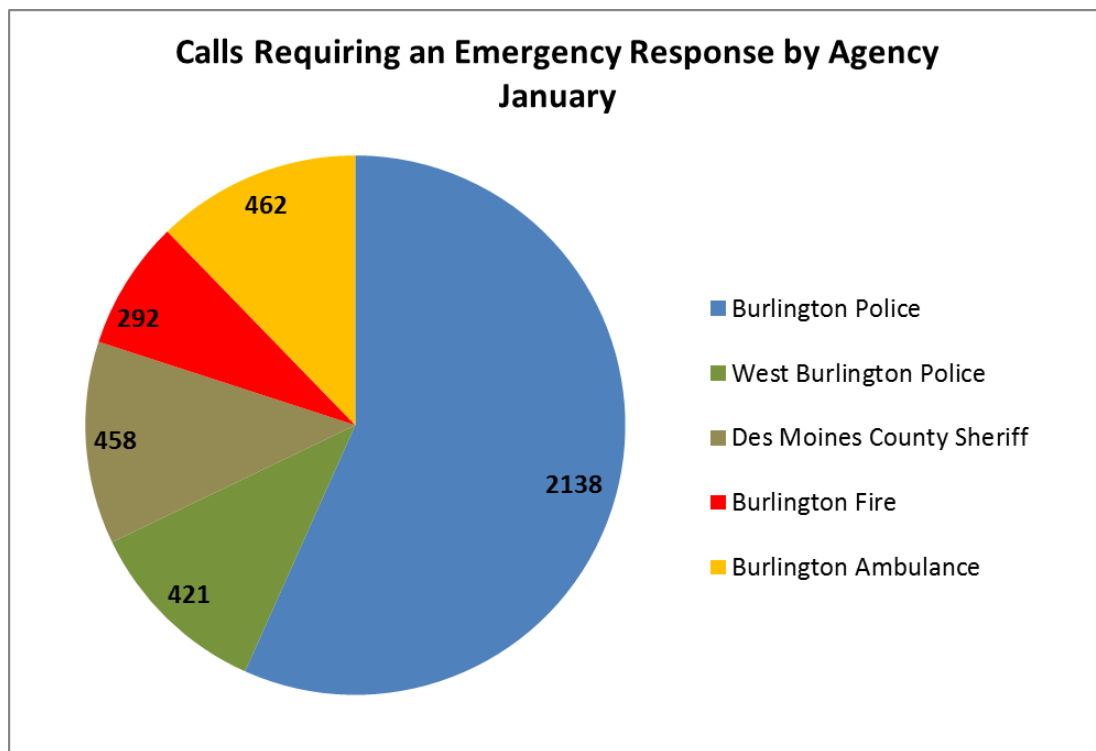

- Lt. Schaefer and Sgt. Venvertloh were presented with their 20-year tenure awards from the City Manager.

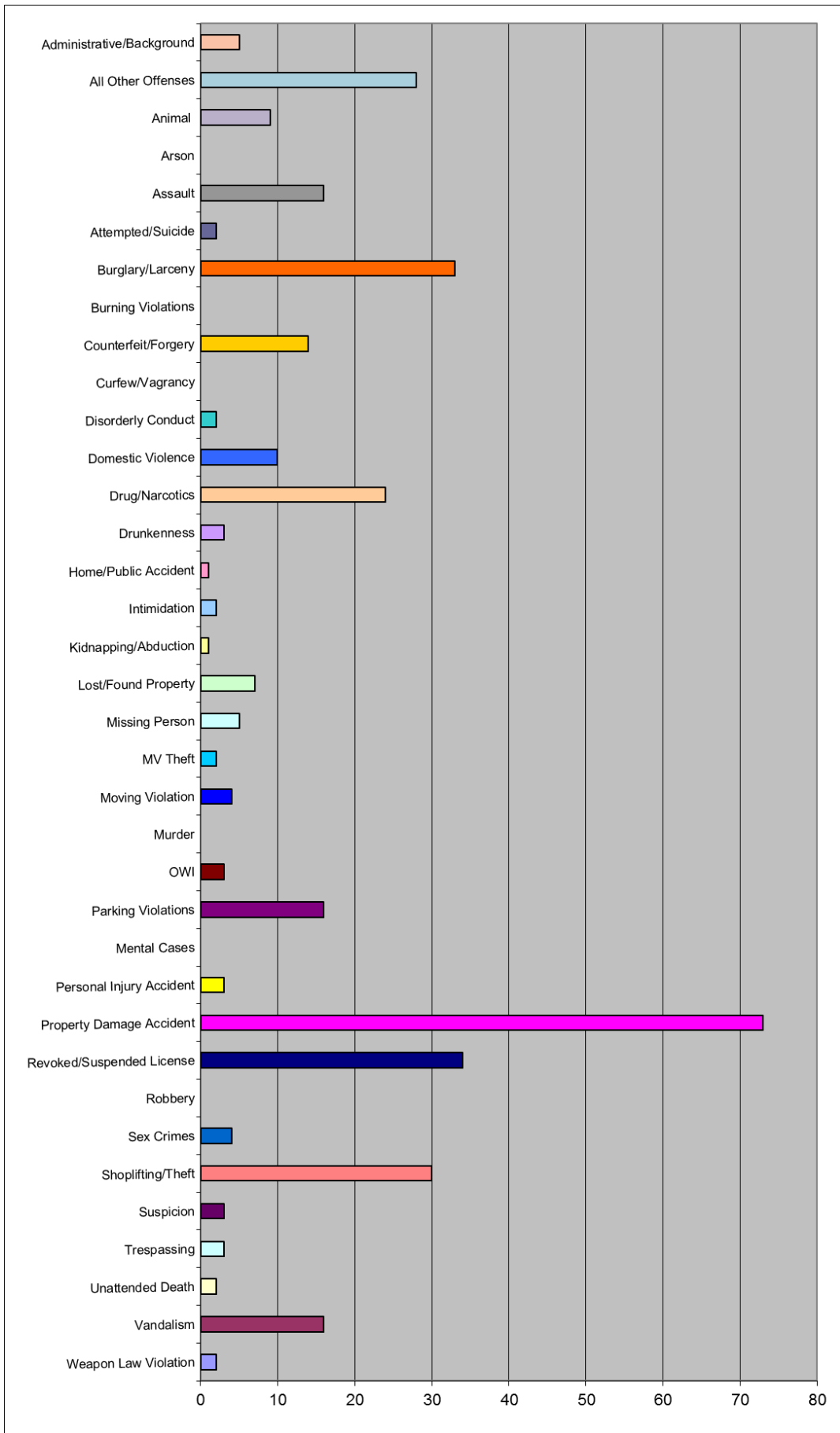
- MMPI tests were conducted on Reserve Police Officer applicants.

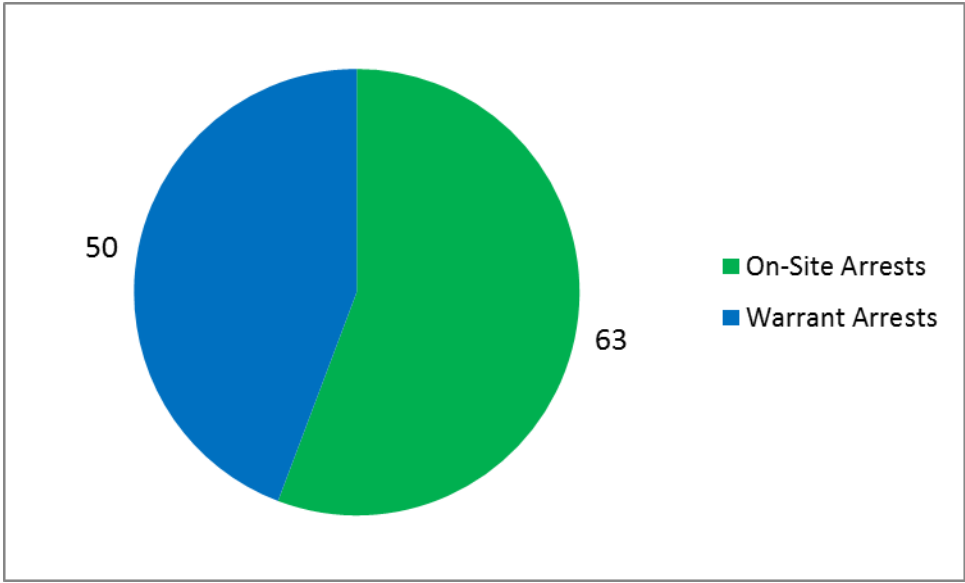

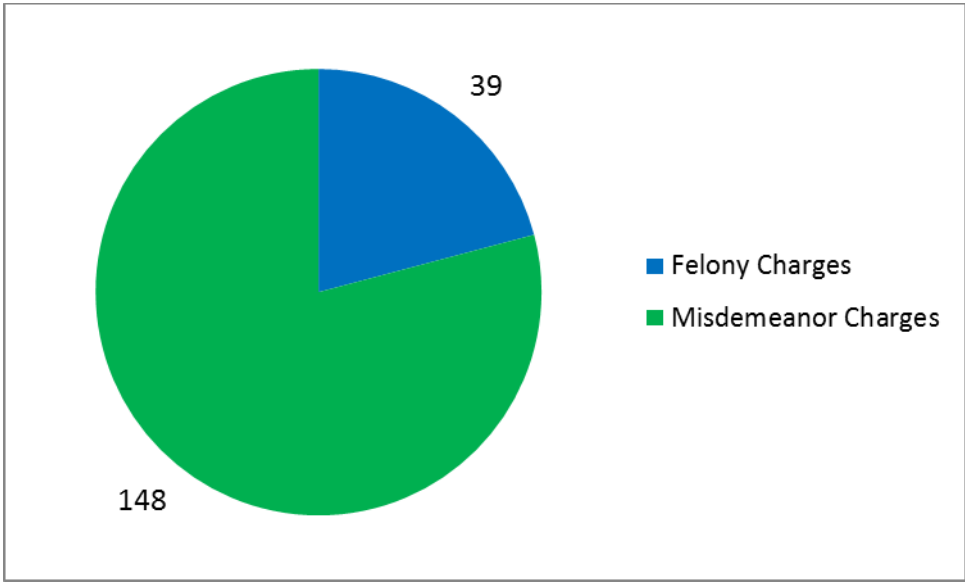
Incidents January 2018
