

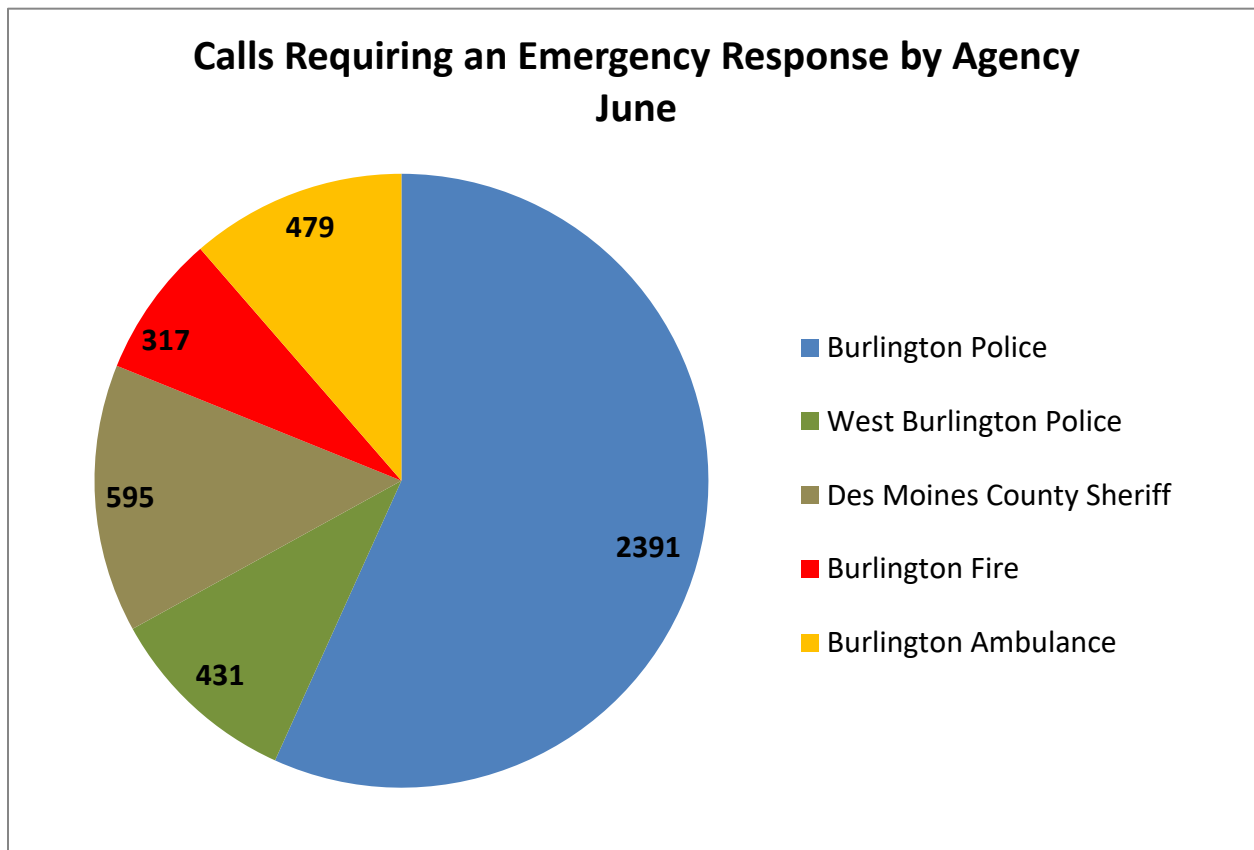

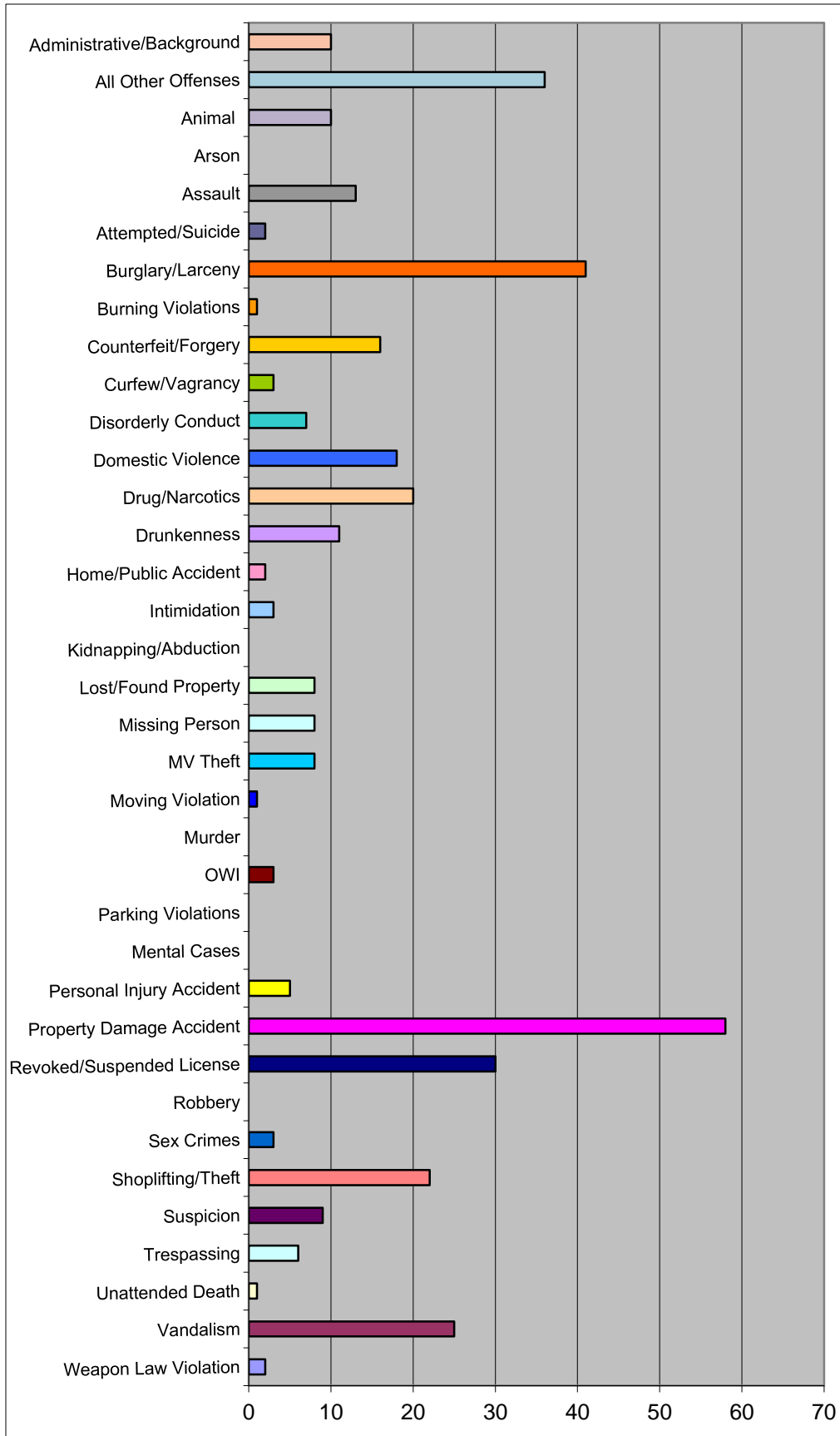

- Chief Kramer participated in the KBUR Peace Officer Talk Show and the E911 Board Meeting and DesCom Advisory and Board meetings.

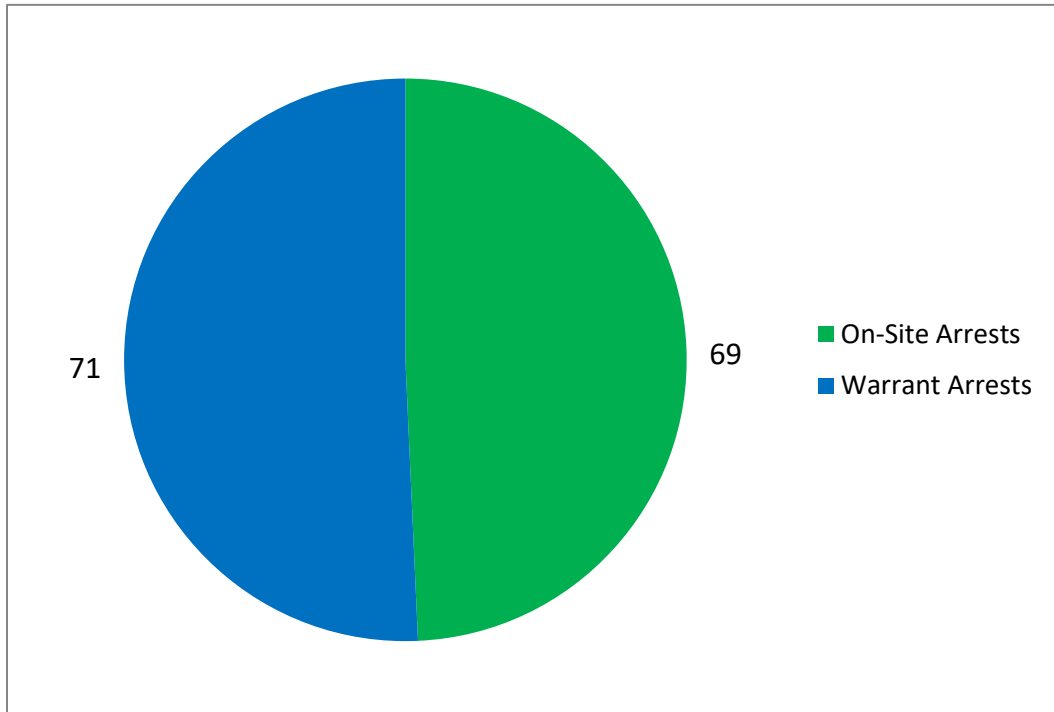
- The Chief and Lieutenant Allen participated in the Southeast Iowa Narcotics Task Force Board Meeting.

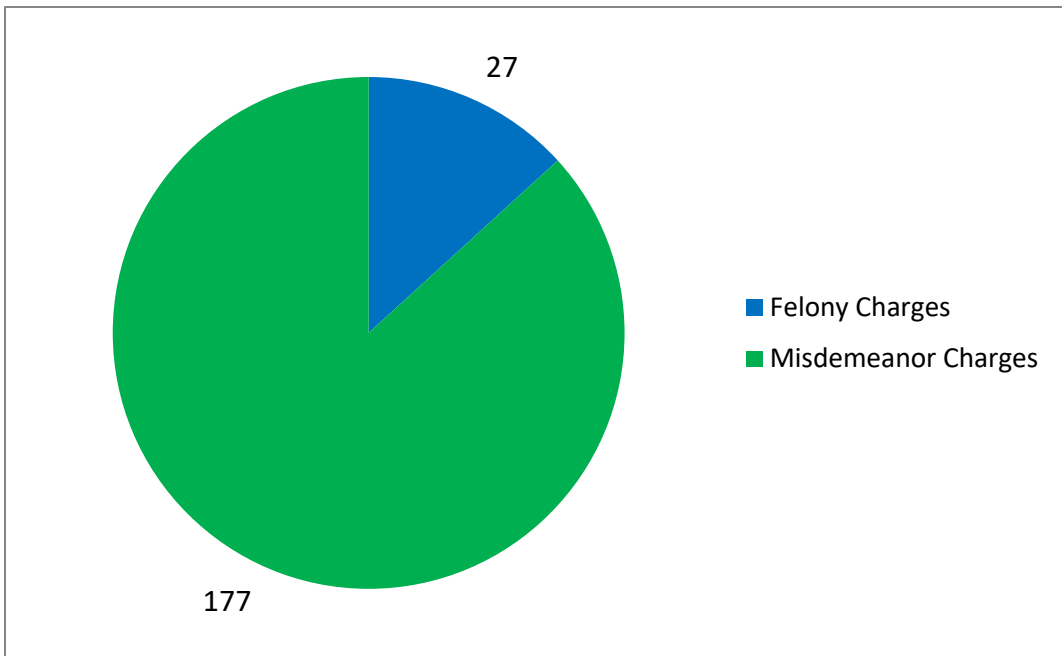
Incidents June 2018
