

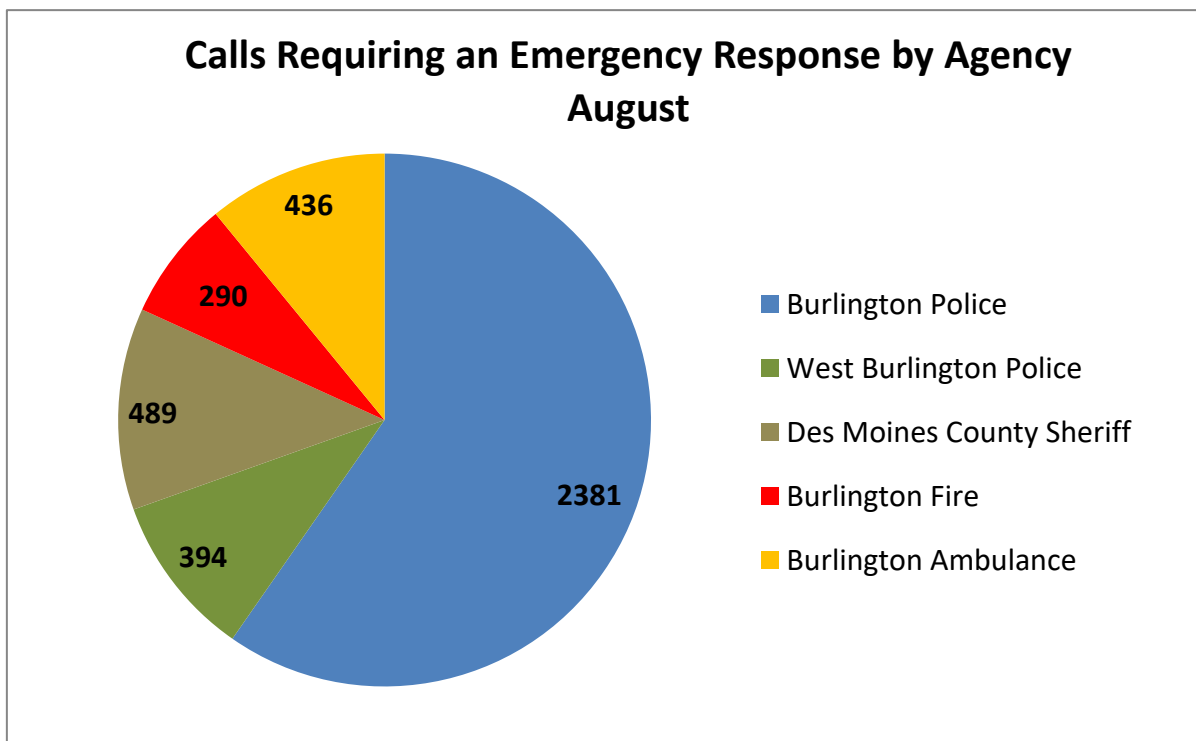

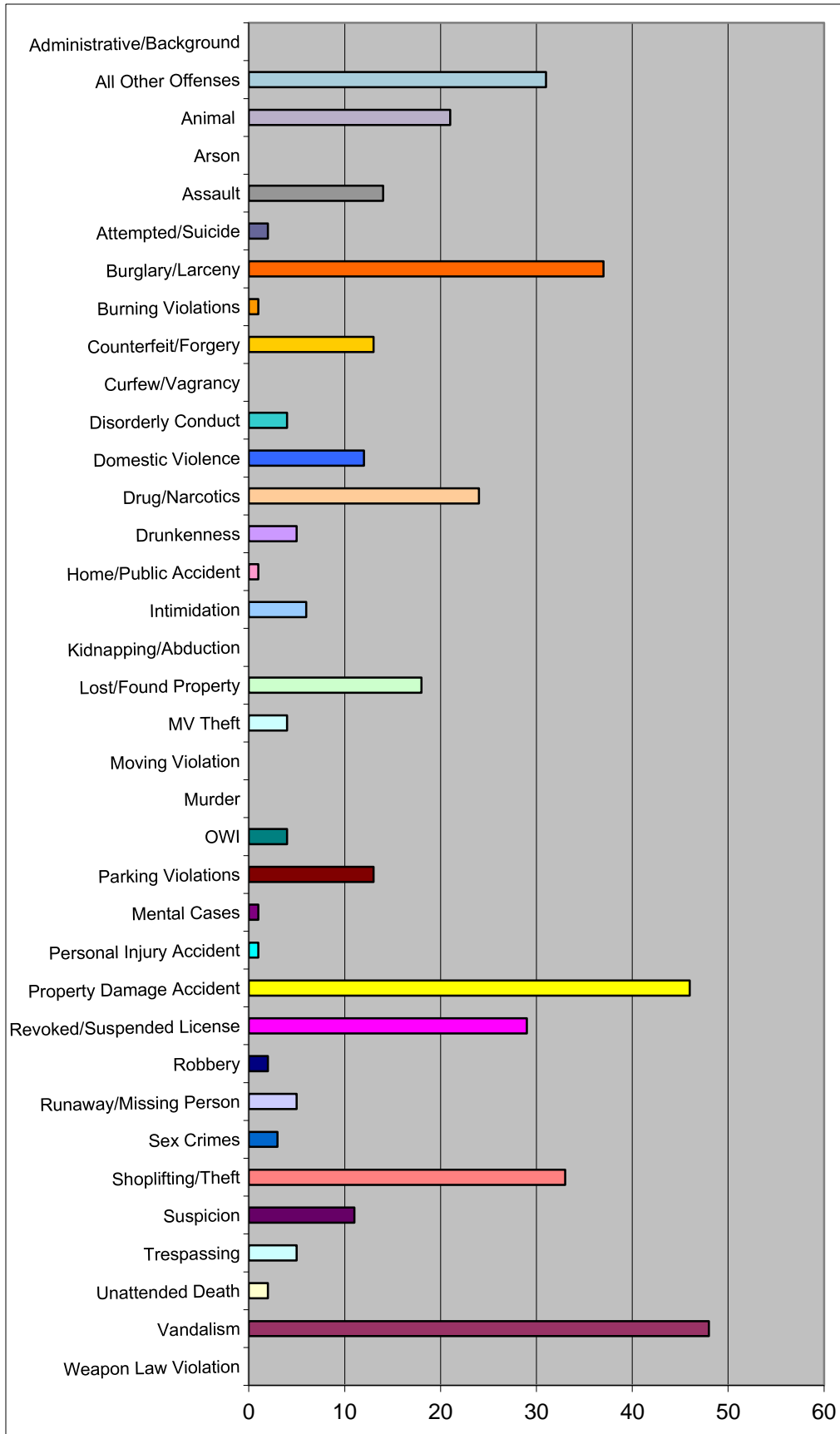

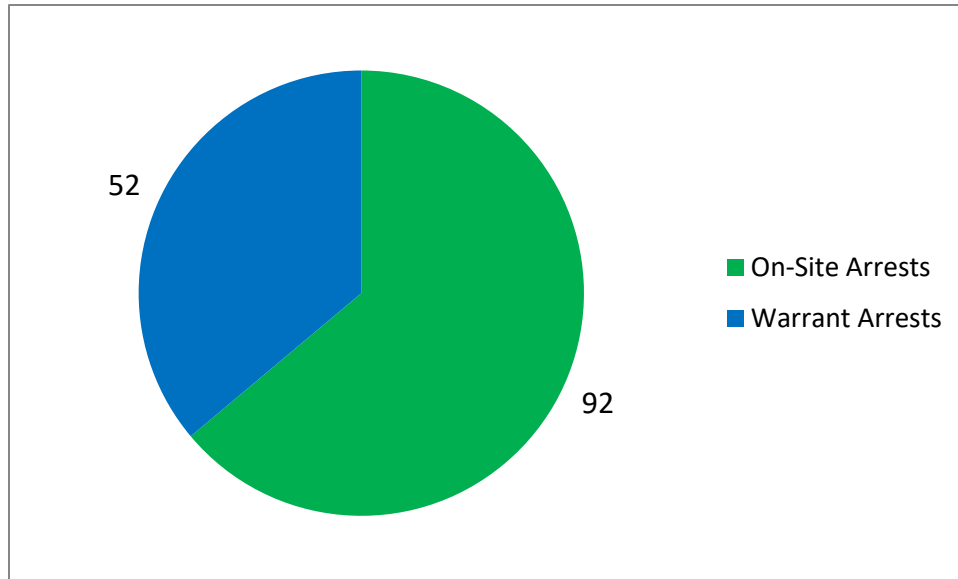
- Lieutenant Thomson participated in the 2nd Annual Youth Police Academy and attended the monthly CrimeStoppers meeting.

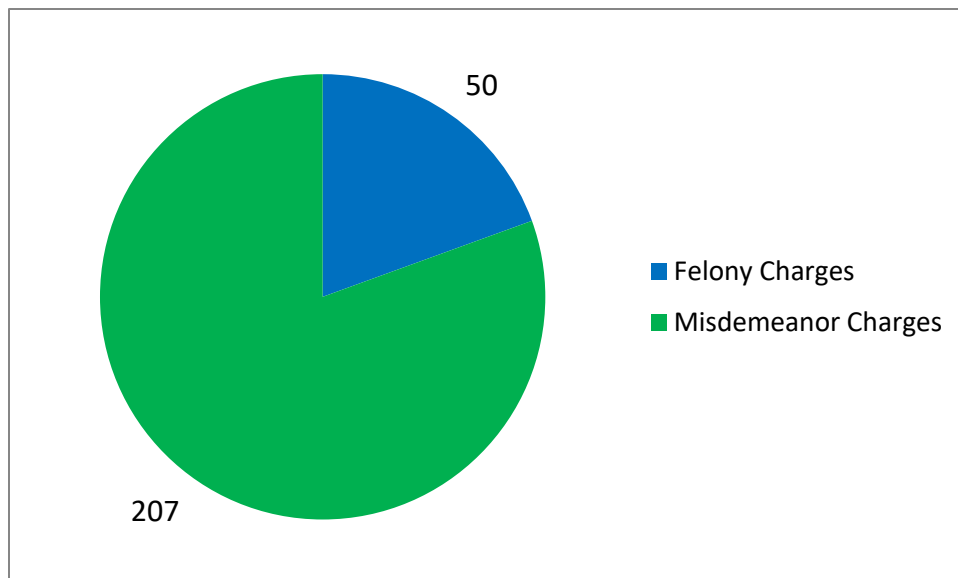
Incidents August 2018
