DISCUSSION: Mayor Davidson reviewed the items listed on the consent agenda to the viewing audience. Council Member Reed announced those individuals appointed to various City commissions and boards. PRESENTATION: North Hill Group Discussion on Rental Property by Ben Brinck

DISCUSSION: David Beckman of 1119 North 4th Street presented the Council with a copy of a petition signed by 108 citizens, most residing in the neighborhood around a 132 year old wooden frame structure originally built as a single family

home which was converted to an apartment building located at 1111 North 5th Street. He stated that the petition requests non-renewal of the rental permit for the apartment at 1111 North 5th Street based on many issues which pose an immediate and serious threat to occupants of the apartment and its neighbors. He stated that many of the safety concerns have been documented through police and fire calls to the apartment. He stated that $\hat{\mathbf{a}}$ grandfathering $\hat{\mathbf{a}}$ should only be

used if the building originally met City Codes as he questioned if the proper building permits were granted for each step of its evolution from a single-family dwelling to a 12-unit apartment. He stated that due to the condition of the building, neighbors have lost appraisal value on their homes. He stated that the message that he and his neighbors have been receiving from City staff is that there was nothing that can be done as the building has been $\hat{\mathbf{a}}$ grandfathered $\hat{\mathbf{a}}$. The Parks and Development Director stated that his office continues to inspect the property. He stated that they have been looking at the

non-conforming side of the Code of other communities. He explained that the property has to be vacant and idle for a year. The Police Chief stated that his

office was implementing the LETS program at the Memorial Auditorium for landlords. Council Member Anderson stated that she felt that a property sitting

idle for a year was a long time, and felt it would be better not to renew the rental permit. She questioned if the property was up to code. The Parks and Development Director stated that the property meets the City $\hat{\mathbf{a}}$ s Housing Code, which is minimum safety standards. He stated that the property does not meet the City $\hat{\mathbf{a}}$ s Zoning Code due to the number of units for the size of the lot. The

Fire Chief stated that the Fire Marshal has done inspections and cannot find a way to make it safer. He further stated that there were many homes in Burlington and especially the North Hill area that are wood frame. Council Member McCampbell stated that he thought the new owner would be rehabilitating the property. The Parks and Development Director stated that the new owner was rehabilitating each unit. Kentrick Page stated that he was the present owner of

the building at 1111 North 5th Street and that he would address any issues, if people feel unsafe. Denise Powell of 915 North 3rd Street questioned what the occupancy was per unit. The Parks and Development Director stated that efficiencies can have one or two tenants. Council Member Reed stated that he was glad that staff was looking at other city codes. Mayor Davidson explained that there was nothing the City Council could do tonight and they need to allow staff to do their job. Council Member McCampbell stated that he felt it was premature to make any statements until the present owner rehabilitates the property. All present had opportunity to speak and nothing additional was filed

in office of the City Clerk.

He stated that the total budget as certified was \$56,502,693.00 with an amendment of \$19,200.00. He reviewed the details of the budget amendment, which included increase in other financing sources from refunding bond issues and transfers, increases in expenditures include bond refunding payments, IDEA bond payment transfers and flood control. Council Member Fleming asked what was the bottom line for the budget amendment. The City Manager stated that the City began the year with \$450,000.00 in the general fund and will end the year with \$940,000.00 to \$950,000.00 in the general fund. He explained that he has moved a lot of money around trying to eliminate deficit accounts and refunding bond issues. He stated that when you move money around from different accounts, the City is required to show it on the budget amendment. He stated that the actual increase

in cost was the 2013 flood. All present had opportunity to speak and nothing additional was filed in the office of the City Clerk.

1. City Manager Evaluation

DISCUSSION: Mayor Davidson stated that each member of the City Council evaluated

the City Manager independently and then he averaged all five of the rankings. He stated that the scale was from one to 10 for job performance in 17 different categories ranging from attitude, quality and quantity of work, communications, efficiency, planning and financial management. He stated that the lowest average score was 8.2 with the highest score at 9.6, which means that the City Manager met and in most cases exceeded the Councilâ s expectations in his job performance. He explained that the City Manager was hired with the expectation that he would provide the leadership to help the Council find its way out of financial difficulties. He stated that Council has not been disappointed. He

stated that the City Manager was highly ethical, principled man who has done an outstanding work in this first year in Burlington. He stated that the Council appreciates the City Manager \hat{a} s many hours of work, his positive attitude and h is

willingness to present ideas and then let the Council make the final decisions. He further stated that normally the City Manager $\hat{\mathbf{a}}$ s evaluation has been done in

a closed session, but the City Manager requested that his evaluation be at an open meeting. Tim Scott of 2017 South 15th Street stated that the City Manager had done a tremendous job and has held nothing back. Arthur Gordon also stated that the City Manager has done a great job. Council Member Reed stated that the

City Manager has done a great job in tough times and thanked him for his open door evaluation. Council Member Anderson stated that the City Manager has not let Council down with their requests. Council Member Fleming stated that the City Manager has done a good job and hoped the City Manager would continue to be

the City Manager for Burlington. Council Member McCampbell stated his appreciation for the City Manager \hat{a} s honesty and that all the Council receives the same information. He further stated that Burlington was blessed to have Jim

Ferneau as its City Manager. Mayor Davidson stated his appreciation of the City

Manager and hoped that he would never leave. The City Manager stated that it has been difficult dealing with financial issues. He stated that he appreciated

that the City Council willingness to work together and also show respect to the public and also to each other. He further stated that he has enjoyed working with the Council. All present had opportunity to speak and nothing additional was filed in the office of the City Clerk.

COMMENTS FROM AUDIENCE: Barbara McRoberts of 919 North 3rd Street presented the Council with a check from Harry and Virginia Murray Foundation in the amount of \$30,000.00 to be used for the Dankwardt Park pool. She stated that people in Burlington want and need the Dankwardt Park pool to remain open. Mayor Davidson

and the Council thanked Barbara McRoberts and the Harry and Virginia Murray Foundation for the check. Jeff Gordon asked why his water bill was always going

up. The City Manager explained that the City was being mandated by the federal level to separate the combined sewers in Burlington. Council Member Reed stated

that he has been working with the Waterworks Board to allow monthly billing and also online bill paying. Barbara Kissinger of 613 Barrett Street suggested to the Council that seniors over 60, disabled and property owners that are single receive a 25% discount on their monthly water bill. Ron Brozene, representing the Southeast Iowa Property Owners Association complimented the Police Department on the implementation of the LETS Program. He thanked the City for being proactive. Kirk Wooldridge of 516 Remick Street stated that he spends a lot of time at the library and hopes that the library does not have further cuts, should the franchise fee not pass. Tim Scott of 2017 South 15th Street, Mike Edwards of 1317 North 8th Street and Jeff Heland of 200 Emmett Street urged

Council to use the Flint Hills Manor property for commercial use verses housing.

They urged Council not to lose sight of the vision for the property. They further stated that John Sandell and Bill Ell were unable to attend the meeting,

but had the same sentiments. All present had opportunity to speak and nothing additional was filed in the office of the City Clerk.
