

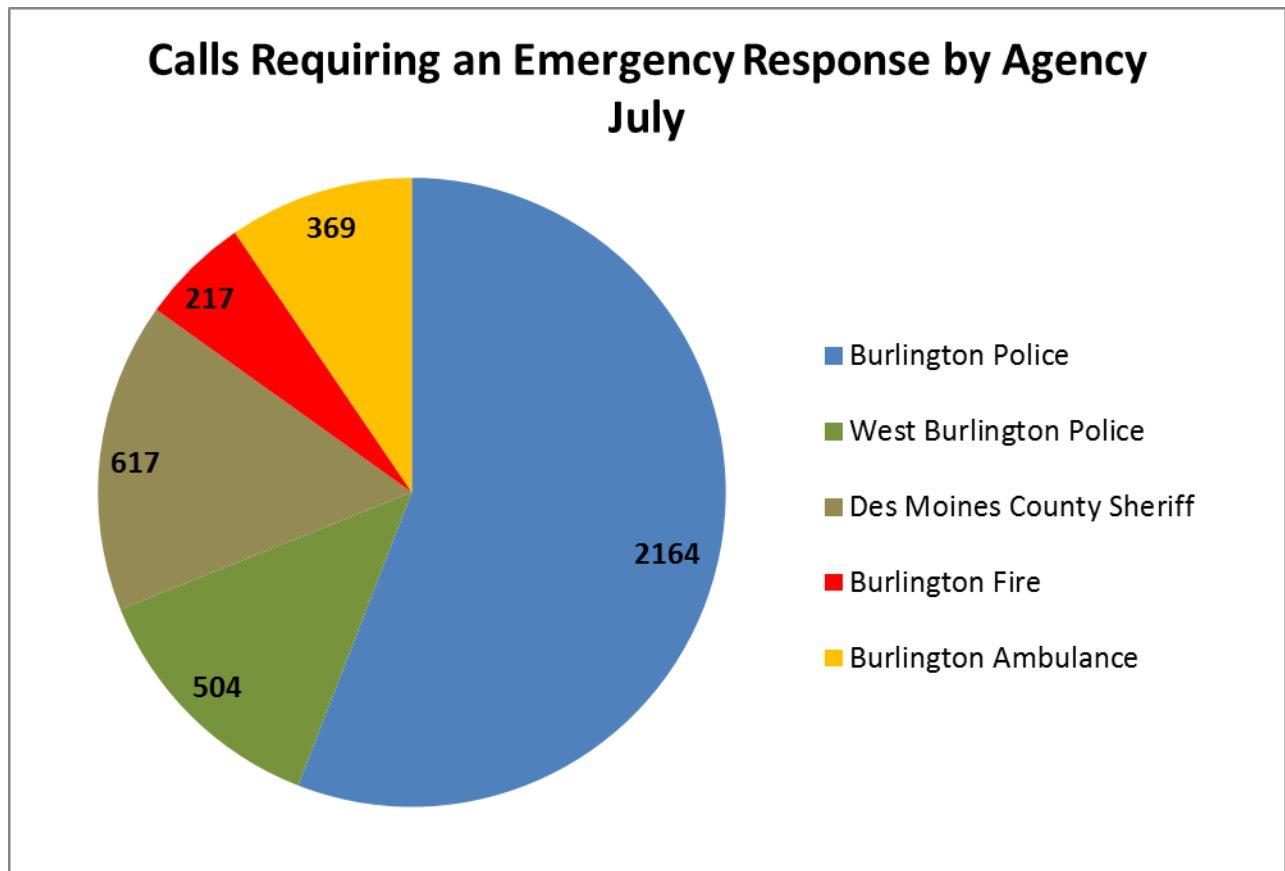

Re: Police Department Activities – July, 2015

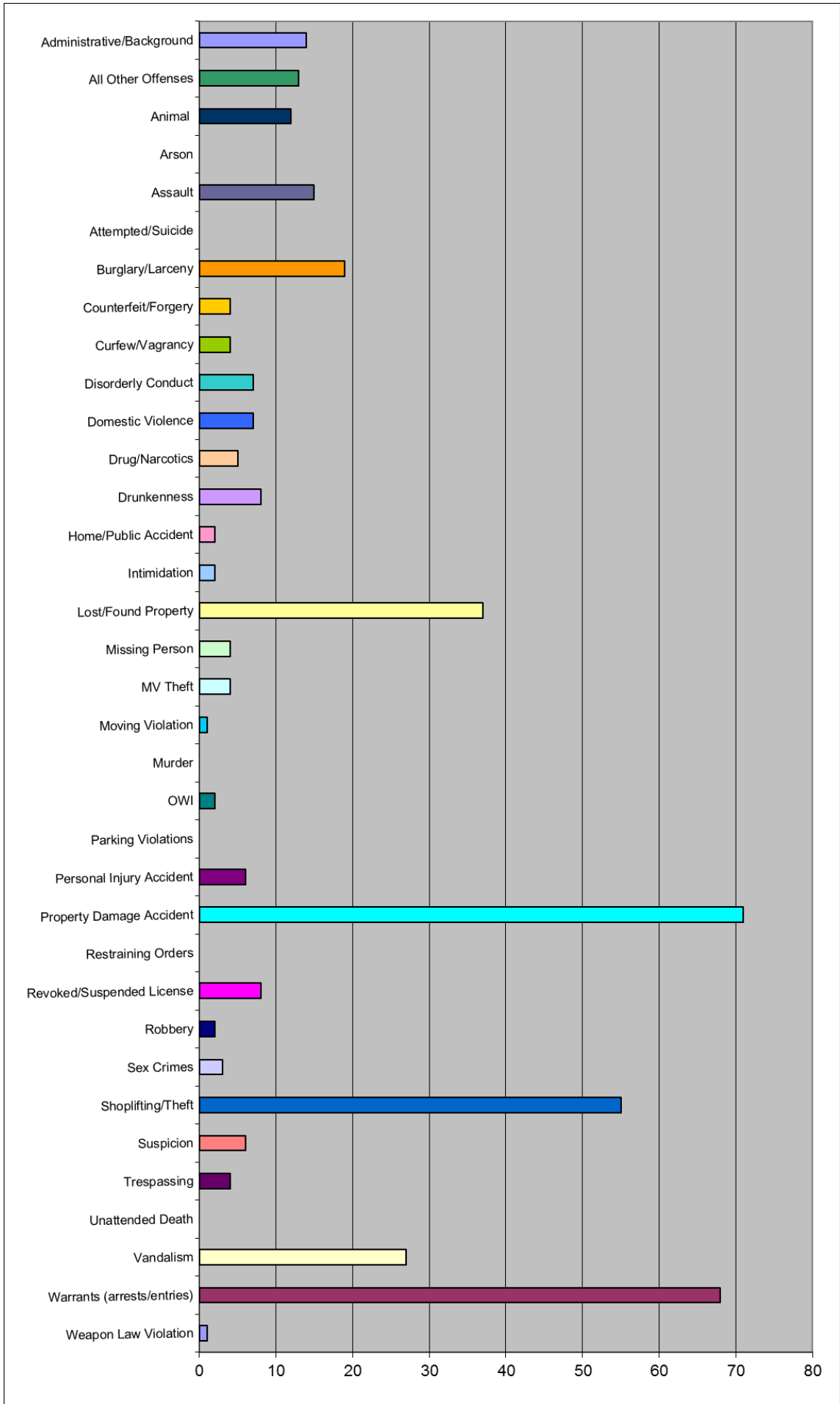


- The Chief attended all City Council Work Session and Meetings.

- Sgt. Thomson met with Denny Becker of the Governor’s Traffic Safety Bureau.

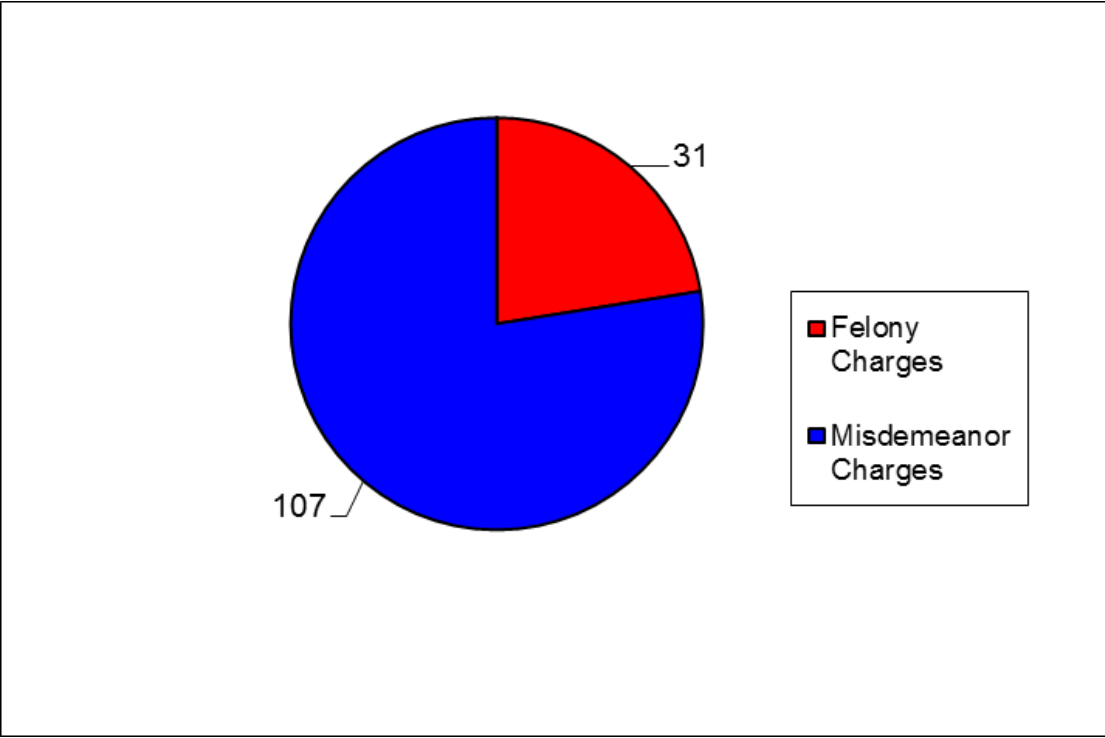
- Major Kramer held a meeting with all current Field Training Officers.

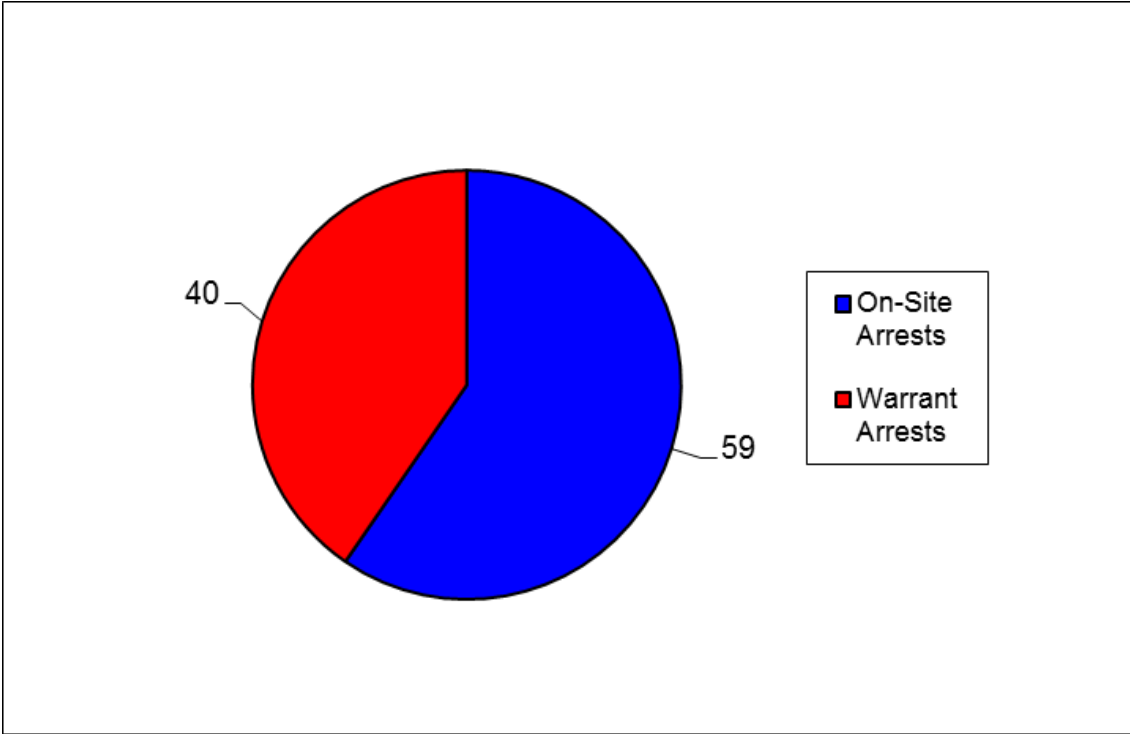
Incidents July 2015
